She also shared that the Riverdale IL Library was having financial difficulties and may be closing. She commented that she was thankful that the Carol Stream Public Library was financially sound.

A. Approval of Resolution #281 FY2018 Working and Appropriation Budgets/Request for Tax Levy

Trustee Lynch moved and Trustee Berryman-Gilliam seconded that the Board of Library Trustees approve Resolution #281 FY2018 Working and Appropriation Budgets/Request for Tax Levy. Motion approved.

Background Information:

The FY2018 Tax Levy will be submitted to the Village for their approval. The levy amount is the same as last year's (FY2017) and there has been no increase. The Library continues to be fiscally responsible and assess all expenditures to optimize savings where ever possible.

B. Approval of Expenses over \$10,000 for Annual Insurance Policy Renewals

Trustee Berryman-Gilliam moved and Trustee Lynch seconded that the Board of Library Trustees approve the annual Insurance Policy renewals. Motion approved.

Background Information:

The Library's current insurance policies are up for renewal in October. The Library's insurance costs decreased by \$746 (2.96%) from last year. Board approval is required for expenditures exceeding \$10,000.

Trustee Lynch commented on the plans that Director has regarding the north lot behind the Library building. She will be applying for grants and working with other organizations to improve the area.
