### III. DISCUSSION

#### A. Library Renovation Project

#### Project Overview:

Library Director Susan Westgate presented an overview of the library's proposed renovation project. The presentation included the goal of the Library's Strategic Plan to "Create a welcoming library environment to attract and engage the community."; the proposed space plan, architect renderings and project estimate of \$5,425,000; Library fiscal history and reserves; Capital schedule/study items that are addressed by the project; project funding – Library has \$3,425,000 in capital reserves for the project, additional \$2,000,000 needed.

Village and Library Relationship:

Village attorney Jim Rhodes reviewed the legal relationship that exists between the Library and the Village through the Local Library Act. The Library does not have the legal authority to issue bonds for the Library; the Village would need to issue a bond on their behalf.

#### Financial Overview:

Municipal Financial Advisor John Piemonte from Ehlers, Inc. presented an overview of the Library's finances and the impact a \$2,000,000 bond/debt would have on a typical Carol Stream homeowner if a 10, 15 or 20 year bond was issued.

## **Optional Funding:**

The Village Board discussed the option of lending the Library the funds from the Village's reserves. The Village staff was directed to meet with Library staff to develop a mutually agreeable funding plan.

There being no further business to come before the Board of Library Trustees, **Trustee Lynch moved and Trustee Bagdonas seconded** that the meeting be adjourned. Motion passed and the meeting adjourned at 7:16 p.m.
