The firms were interviewed by the Director, Assistant Director and two members of the Library Board. Following the interviews, references were checked and the interviewees came to a consensus to recommended that FQC Construction Management meet with the Board of Trustees for consideration for overseeing the construction management of the Library's renovation project. Four team members of FQC Construction Management presented information about their firm and their approach to the Library's project. In addition they shared information about their experience and expertise in Library and other municipal construction projects and answered questions from the Board.
