Recommendation, Re: Approval of Zinio Annual Online Magazine Subscriptions

Background Information:

The annual subscription fee for the Library’s online magazine service Zinio is in the amount of \$10,183.20. This cost is for 106 online magazines including *The Economist*, *US Weekly*, *HGTV* magazine, *Good Housekeeping*, *Food Network* magazine, and others. Last year our patrons checked-out 2811 issues. The average cost per title is \$96.07 and the average use per title is 23 downloads. Some of the more popular magazines are: *The Economist* at 53 circs (which is twice the print circulation rate); *US Weekly* at 152 circs; and *Food Network* at 74 circs. This will be paid out of the Digital Media budget line 5651. Board approval is required for purchases exceeding \$10,000.

The Library Board of Trustees approved the disbursements for the period February 1, 2017 to February 28, 2017, plus the Addendum for the Meeting of March 15, 2017 in the amount of \$99,669.37.

Two of the kiosks will be retro-fitted for the update. It is necessary to replace an old model as it does not have the capability to be retro-fitted. In addition to the debit/credit cards, the converted kiosks will have the capability to take payment from various mobile pay vendors. The cost of the conversion is \$10,520. Board approval is required for purchases exceeding \$10,000.
